We are committed to helping each student driver reach his or her full potential as a safe, perceptive, defensive driver. In doing so, we teach driving fundamentals by putting student drivers in different driving situations to help them gain experiences that they will use throughout their many years of safe driving.

These are your choices for our Behind-the-Wheel Programs at 1st Steps Driving School:

- **Package A** - Is the most common driving package. It includes 6 hours of driving instruction for a flat fee of **\$285**

This 6 Hour Package Includes - 4 Lessons of 1 ½ Hours or 3 Lessons of 2 Hours

- **Package B** can only be used after package A is completed. It offers extra driving sessions for individual drivers needing extra lessons to become experienced enough to master the skills necessary to complete their driver's licensing test.

- **Package C** is assessed on an individual per hour rate for each scheduled driving session.

- **Package D** is an online educational package for drivers' education. It includes an online class equivalent to 30 hours of classroom instruction for drivers' theory. Quizzes and Tests must be passed to complete the online instruction successfully.

Furthermore, this is a great way for students to prepare for the Pennsylvania Drivers Permit Examination. **The flat fee for the online class is \$75.**

- **Package E** is a combination of Packages A & D. This package includes the online class (\$75 value) + 6 hours of on road driving instruction (\$285 value) for a flat fee of **\$335**.
- **Certificate** - Once the student completes at least 6 hours of behind-the-wheel driving, he or she will receive a certificate that the driver can show to his or her insurance company. Most insurance companies give an insurance premium discount of 5%, 10%, or 15% off the cost of the insurance premium. Also, we will sign a form so that a student may receive his or her unrestricted license early if applicable.
- **Cancellation Policy**
 - If a student has to cancel a driving lesson, he or she must notify the instructor at least 24 hours in-advance and it will be made-up at the instructor's earliest convenience.
 - If a lesson is missed, without cancellation, one half hour of individual driving time will be assessed to the student driver's account and must be paid upon the next driving lesson. The missed time will be rescheduled at the instructor's earliest convenience.
 - If an instructor has an emergency, then the instructor will notify the student as soon as possible and reschedule at the student's earliest convenience.
- **Return Check Policy** – There will be \$40 fee for returned checks before we will drive again.
